All applicants must <u>meet the current eligibility requirements at the time the completed application package is received at the Board office</u>. Completed application packages must include all required documentation, references, verifications, and fees. All forms must be legible. After applicants pass the Fundamentals of Engineering exam, they may apply to the Board for the Engineer-in-Training designation.

# **REQUIREMENTS FOR DESIGNATION**

Examination Applicants (applicants who have passed the FE exam)

- > Engineer-in-Training Designation Application and fee;
- Engineer-in-Training Reference Form (less than one year old) completed by a licensed professional engineer, the dean of the engineering school, a department professor in the school attended by the applicant or an immediate supervisor (all references must have known the applicant for at least one year) and been associated with the applicant within the last 5 years;
- > <u>Degree Verification Form</u> or official school transcripts;

# EDUCATION

All applications are evaluated based on the undergraduate degree held by the applicant (*unless the applicant holds a graduate degree which is ABET accredited at the graduate level*). Applicants should forward the <u>Degree Verification Form</u> to the college or university from which any degree(s) were obtained (unless official school transcripts are required). In order to receive the EIT Designation, candidates applying must submit a completed <u>Degree Verification Form</u> or an official transcript.

Applicants who have earned a degree from an institution outside the United States must have their degree authenticated and evaluated by an education evaluation service if credit is sought for this education. However, if the applicant also holds an equivalent or higher-level engineering degree from a United States institution where the program has been accredited by ABET, no evaluation is required; however, the degree must be verified using the **Degree Verification Form** or official transcript. The Board reserves the right to reject an evaluation submitted by an applicant. AN EVALUATION DOES NOT CONSTITUTE ABET ACCREDITATION.

### TOEFL iBT

Applicants for licensure must be able to speak and write English to the satisfaction of the Board. Applicants from a non-English speaking country or a country where the primary language is not English, who have not graduated from a college or university in which English is the language of instruction, shall submit to the Board a TOEFL iBT (Test of English as a Foreign Language) score report that reflects a score acceptable to the Board. Score reports shall not be more than two years old at the time of application.

In lieu of the TOEFL, other evidence such as significant academic or work experience in English may be acceptable as determined by the board.
